The grant money was used for: native plants, irrigation tubing, garden design and planting supervision, and (yet to be purchased) wood to make the NPSacknowledgement sign (with assistance from a volunteer woodworker through Mesilla Valley Audubon Society). Remaining money has been encumbered at the ASCMV for replacement plants in case some of them don't make it through the first winter. If all of them make it (fingers crossed), we'll look at what's thriving andadd that and more to the garden in February as the weather warms up (and provide an update to youand our local chapter then).

The first thing ASCMV had to do was, unfortunately, find a new garden designer.Robledo Vistawas unexpectedly conflicted out due to a co-owner'semployment with the City of Las Cruces, which is the ASCMV fiscal agent. (His job is totally different, but that didn't seem to matter.) Joan Woodward graciously provided several names and we worked with Jackye Meinecke. She designed the garden, chose the plants from native plant vendors, and worked with the ASCMV maintenance engineer to set up the irrigation. Jackye worked with volunteers from the local chapter of NPS and Mesilla Valley Audubon Society (there is some crossover!) for the planting on October 8 and she was on-site to supervise. Twenty-two plants were planted in the first round and set up with irrigation according to Jackye's instructions.As noted in the application, we realize it takes a couple years for natives to establish; however, they are set up for irrigation and nature is hopefully taking hold.

Our project furthers the NPS mission in a couple of ways. First, restoration of native plants. Since the project inception, evenmore land across and along the highway where our facility is located has been cleared for commercial development. By providing a little native oasis in this (formerly) barren spot, we most importantly are trying give the buggies a place to land and find sustenance. Secondarily, we hope to provide inspiration for ASCMV employees and visitors to learn about andplant hardy natives that survive and hopefully thrive in a hot, exposedlocation. Hopefully itbecomes asource of enjoyment and pride for hardworking ASCMV employees as the garden matures.

I am personally committed to this project because of my own interest in native plants as part of the ecosystem, particularly for birds (I am involved with Mesilla Valley Audubon). I'll be the one following through on the signage and springtime planting.

To my mind, one benefit of this gardenis that it'saway to introduce some ideas about helping the environment to a group of people (ASCMV staff) that mostly don't seem to have had much exposure. Since the beginning of thae year, I've also started a plastic recycling "program" (okay, it's a garbage can for bottles that I recycle, but it's a start), I go out a couple/few times a month and litter-pick trash (not sure what people think about that),I'm inviting ASCMV staff on a bird walk in January, and, thanks to the Carter grant, there is going to be a thriving garden full of native plants. I (and perhaps Jackye and/or an NPS-LC representative, depending on how much time I am given) will be talking about the project in the January staff meeting, giving a rundown of what's there, the work that was involved in putting it in, and how and why these plants are helpfulin the environment, how ASCMV staff can be involved in maintaining the garden, and what they can look for in the garden.

The most important thing, though, is that this garden will be ahighly visible and environmentally impactful spot in an area that desperately needs it. I can't wait until spring to see what flourishes, what insects visit, and what we can add!
